Each of the Resolutions put to the Irish High Court Convened Shareholder Meeting and Extraordinary General Meeting (the "Meetings) on 8 June 2023 was decided by way of a separate poll. All Resolutions were carried, as set out in the tables below. As at 8 June 2023, the total number of Ordinary Shares in issue (excluding Treasury Shares) was 730,943,752. Accordingly, the total number of votes cast at the Meetings represent approximately 73.92% of the total issued share capital.
